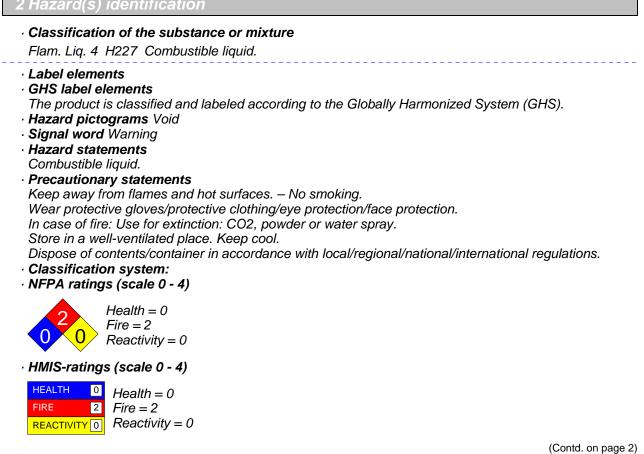

Protective gloves
